CHECK the Vehicle Recovery Ring is properly attached using a hitch pin and clip.

KEEP OUT of the Danger Zone

- Bystanders can be struck by recovery strap recoil or unexpected movement of the vehicles.
- ALWAYS move bystanders a safe distance from the recovery area.
- KEEP OUT of the recovery vehicles path.
- NEVER stand in front of, between or behind vehicles during recovery. Vehicles could move suddenly and unexpectedly.
- ONLY persons involved in the recovery should be in either vehicle.

AVOID shock loads

- DO NOT impact, jerk and/or swing the load during recovery. These actions can overload your Vehicle Recovery Ring and cause it to break or detach.

NEVER use for conventional towing of vehicles, trailers or RVs on the roadway
