540-SS Sunscreen Installation Instructions

Before you begin ****See other important information on the back of this sheet.****

- 1. Do NOT leave young animals unsupervised for extended periods of time.**
- 2. Be sure to remove the collars and tags from your pet before placing it in the exercise pen to prevent possible entanglement.**

Note: Exercise Pen **MUST** be set-up in a square for top to fit properly

- 16 - Plastic Wire Ties
- 1 - Sunscreen Shade Cover

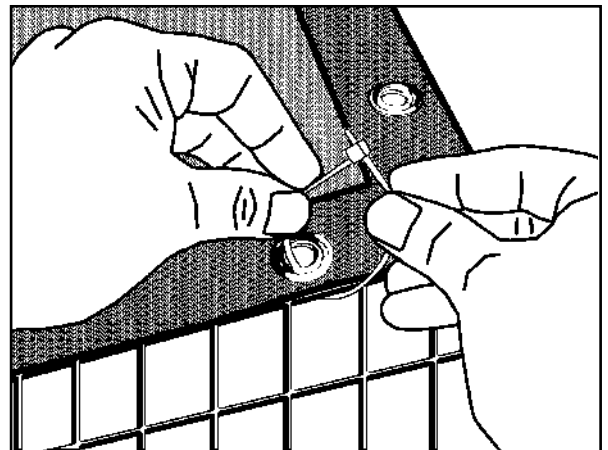


Installation Instructions

Note: If you discover any parts are missing, immediately call our toll-free service helpline at 1-800-428-8560 between 9:00 am and 4:00 pm (EST) Monday through Friday.

1 Unfold the Shade Cover and, using the Plastic Wire Ties, loosely attach it to the Top Wire of the Exercise Pen at each corner. **DO NOT PULL THE WIRE TIES TIGHT!**

2 After the corners have been attached, loosely affix a Plastic Wire Tie at each grommet on the Shade Cover as shown. Starting at one corner, pull the Wire Tie a bit tighter. Work your way around to each corner, pulling the Wire Ties tighter and tighter until they are all snug. Now work your way around the Exercise Pen, pulling the remaining Wire Ties up as you go.



NOTES:

We suggest removing and storing the Shade Cover when not needed to shade your pet. Do not allow snow or debris to collect on top of the Shade Cover.

Occasionally, even rain will collect. Remove it as soon as possible. Injury to your pet and damage to your Exercise Pen may occur if the load is not removed. Properly cared for, your Shade Cover will provide years of service and protection for your pet. Replacement Plastic Wire Ties can be purchase at most hardware stores and home improvement centers.

LIMITED MANUFACTURERS WARRANTY

1. For one (1) year from the date of original purchase, MIDWEST Homes For Pets ("MIDWEST") warrants to the purchaser of this exercise pen top that, should it prove defective by reason of improper workmanship and/or material, MIDWEST will repair or replace, at its option, any defective part of the exercise pen top, without charge for the part or for shipping. Replacement parts are warranted for the remainder of the original period.
 2. **THIS WARRANTY DOES NOT COVER** defects in the wire enclosure caused by any animal, any physical abuse to or misuse of the exercise pen top, any damage caused by the original purchaser or any third party, or any defects arising or discovered more than one (1) year from the original retail purchase date.
 3. **STEPS TO OBTAIN WARRANTY SERVICE:**
 - A. The purchaser must call MIDWEST's HELPLINE, 800-428-8560, to report the alleged defect to a customer service representative or obtain missing parts.
 - B. The customer service representative will determine if the defect is covered by this warranty, and if it is, will authorize and instruct the purchaser in how to obtain corrective action.
 - C. MIDWEST may require the purchaser to present the sales receipt or other proof of purchase prior to authorizing any return or replacement. No returns or replacements will be permitted without proper authorization. If a return or replacement is authorized, you may be requested to return the item to MIDWEST or to make the item available for pick-up by MIDWEST.
