
- 1. Do NOT leave young animals unsupervised for extended periods of time.
- 2. Be sure to remove the collars and tags from your pet before placing it in the exercise pen to prevent possible entanglement.

Note: Exercise Pen MUST be set-up in a square for top to fit properly

8 - Swivel Snaps


1 - Wire Mesh Top




Installation Instructions

Note: If you discover any parts are missing, immediately call our toll-free service helpline at 1-800-428-8560 between 9:00 am and 4:00 pm (EST) Monday through Friday.

- With Exercise Pen set-up in a square, lay the folded Top over one end. Be sure the edges of the Top overlap the sides of the Exercise Pen.
- Unfold the top, being sure that the edges of the Top overlap the sides.
- Hook the Top to the Exercise Pen using the Swivel Snaps. For maximum protection, place the Swivel Snaps in the locations illustrated. Be sure to hook at least one wire from the Top and one wire from the Exercise Pen at each location.

- Be sure to remove the collars, tags and leads from you pet before placing it in the home to prevent possible entanglement.

LIMITED MANUFACTURERS WARRANTY

- 1. For one (1) year from the date of original purchase, MIDWEST Homes For Pets ("MIDWEST") warrants to the purchaser of this exercise pen top that, should it prove defective by reason of improper workmanship and/or material, MIDWEST will repair or replace, at its option, any defective part of the exercise pen top, without charge for the part or for shipping. Replacement parts are warranted for the remainder of the original period.
- 2. THIS WARRANTY DOES NOT COVER defects in the wire enclosure caused by any animal, any physical abuse to or misuse of the exercise pen top, any damage caused by the original purchaser or any third party, or any defects arising or discovered more than one (1) year from the original retail purchase date.

3. STEPS TO OBTAIN WARRANTY SERVICE:
A. The purchaser must call MIDWEST's HELPLINE, 800-428-8560, to report the alleged defect to a customer service representative or obtain missing parts.
B. The customer service representative will determine if the defect is covered by this warranty, and if it is, will authorize and instruct the purchaser in how to

obtain corrective action.

C. MIDWEST may require the purchaser to present the sales receipt or other proof of purchase prior to authorizing any return or replacement. No returns or replacements will be permitted without proper authorization. If a return or replacement is authorized, you may be requested to return the item to MIDWEST or to make the item available for pick-up by MIDWEST.
