



Hitch Extension (for 2 x 2 Receiver Hitch)

Instructions for use

Contents:

- 1-Hitch Extension Assembly (includes anti-wobble device)**
- 1-Receiver Hitch bolt (5/8" x 1.5")**
- 1-Receiver Bolt Lock Washer**

Precautions:

- **This product is NOT to be used for TOWING of anything, in any way!**
- The unit is quite heavy for its size, please handle with caution.
- When not in use it is advised to remove the Hitch Extension from the vehicle and store in a sheltered/dry location, or in the vehicle (securely) until use is necessary.

Installation:

- Once removed from the carton, insert the Hitch Extension into the 2" x 2" receiver until the holes in the Hitch Extension and hitch line up. There are two holes in the Hitch Extension available for this. Use the hole that allows for as little leverage on the Hitch Extension as is possible.
- After aligning the holes, place the washer on the bolt and thread the bolt into the unit (inside the blue nut retainer) and then tighten with a proper wrench to insure the bolt is very tight and secure. This is very important. Finger-tight is not adequate. Note there is a blue nut retainer. This is the anti-wobble device and it can be positioned to either hole in the Hitch Extension. You can easily move this by pushing it gently with a flat screw driver.
- After tightening the receiver hitch bolt, insert the bike, motorcycle or cargo carrier into the Hitch Extension and align the holes similarly to the previous method. Insert your pin or bolt and tighten as noted above. If you have an Advantage[®] Sports Rack, there is an anti-wobble device in it most likely. Be sure to use the hole where the nut is aligned with the hole in the larger end of the Hitch Extension.

Limited Liability, Two-Year Warranty Policy

Heininger Holdings, LLC, warrants the original owner of each new Advantage® Sports Rack against defects in workmanship and materials for two years from the date of purchase (at retail) of the product, provided it is purchased from an authorized Advantage® Sports Rack dealer. This Limited Two Year Warranty is not transferable and shall only apply to normal and ordinary use, for which the product was intended.

Warranty claims are to be made directly to Heininger Holdings and must be accompanied by a sales receipt or other appropriate proof-of-purchase document. Should this sports rack or any part or accessory be determined by Heininger Holdings, to be defective and covered by this Limited Two Year Warranty, it will be repaired or replaced at the option of Heininger Holdings, without further charge. The cost of transportation to and from the Heininger warranty inspection facility for repair or replacement of any defective part and/or accessory and any related charges is not covered by this warranty, and is to be paid by the owner.

The warranty does not cover normal wear and tear, worn and normal use cosmetic blemishes, improper assembly, lack of maintenance, or custom alteration/installation of any parts or accessories not originally intended or compatible with the product as sold. The warranty does not apply to damage or failure resulting from an accident, abuse or neglect.

This warranty is given in lieu of all other expressed warranties, implied warranties, including without limitation implied warranties of merchandising ability and fitness for a particular purpose, and are limited to the duration and specification of this warranty. In no event shall Heininger Holdings, be liable for damages in excess of the purchase price of the Advantage® Sports Rack, for any loss of use, loss of time, inconvenience, commercial loss, lost profits or savings or any incidental, special, consequential, direct or indirect damages arising out of the use or inability to use such product, to the full extent as such may be disclaimed by the law. Labor charges for part changeover are not covered by this warranty.
