LIMITED WARRANTY

- The supplier whose name and address are on the reverse side warrants each kerosene heater to be free from defects in material and workmanship for two (2) year from the original retail purchase date. This warranty applies to normal use and service only and is subject to the terms and conditions listed below.
- This warranty is made to the original retail purchaser. Any claim made under this warranty must be accompanied by a copy of the proof of the original purchase such as a cancelled check or a sales receipt.
- Normal wear and tear of parts is not covered by this warranty. This includes the following items: igniter coil, siphon, wick adjuster.
- Should any heater covered by this warranty prove defective in material and/or workmanship during the two (2) year period, the defective product or part will be repaired or replaced at the option of warrantor.
- In order to receive service or parts under warranty, contact the nearest authorized service center.
- In the event it is necessary to return the heater, it must be repacked in its original factory carton with the original packing material. If the carton and packing material were disposed of, order them from your dealer or service center.
- Empty all kerosene from the fuel tank before packing for shipment to your service center.
- The entire unit should be returned to your nearest service center. Shipping costs are the responsibility of the customer.
- Please include a brief description of the difficulties experienced. Be sure to consult the Quick Cures to Common Troubles page in your owner's manual. For detailed technical information and assistance call the supplier who's telephone number is listed on the reverse side.
- Should a heater be returned for a cause not covered by this warranty, any repairs, handling, or testing will be made at owner's expense.
- Any damage that may occur to the heater during shipment from the original retail customer or on the return shipment to the retail customer will not be the responsibility of the warrantor.
- No one has the authority to add to or change the terms and conditions contained in this warranty or make any express warranty other than this.
- This warranty shall not apply to malfunctions caused by failure to operate or maintain the heater in compliance with the instructions furnished in the owner's manual, unreasonable use, use of any fuel other than pure kerosene, use of a replacement wick not approved by the manufacturer, accidents or negligence.
- ALL IMPLIED WARRANTIES, INCLUDING, BUT NOT LIMITED TO, ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS, ARE LIMITED IN DURATION TO THE DURATION OF THIS WRITTEN WARRANTY. REPAIR OR REPLACEMENT AS STATED HEREIN IS THE OWNER'S SOLE REMEDY. THERE SHALL BE NO LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. INCLUDING BUT NOT LIMITED TO, LOSS OF USE, INCONVENIENCE, LOSS OF TIME, OR DAMAGES TO ANY BUSINESS OR PROPERTY. WHETHER AS A RESULT OF BREACH OF WARRANTY, NEGLIGENCE, STRICT LIABILITY IN TORT, OR OTHERWISE.
