

## STEP 1- SEE FIG. 2

PLACE TENSION ROD INTO GUN/BOW RACK ASSEMBLY.

2- GUN/BOW RACK ASSEMBLIES WITH PRE-INSTALLED GUN/BOW CLIPS 2- ADJUSTABLE TENSION RODS WITH PRE-INSTALLED NUT AND LOCK NUT \*\*NOTE\*\*THE FLAT WASHER IS TO BE INSTALLED BETWEEN THE JAM NUTS & THE **GUN RACK BODY** 



## STEP 2- SEE FIG. 3

SELECT DESIRED LOCATION FOR PRODUCT PLACEMENT ON ROLL BARS OF UTV AND ADJUST TENSION ROD OUT TO FIT BETWEEN ROLL BARS.

## STEP 3- SEE FIG. 4

TIGHTEN NUTS ON TENSION RODS WITH FINGERS UNTIL SNUG.

TIGHTEN NUT AND LOCK NUT SECURELY WITH WRENCH.

#### \*\*NOTE\*\*

MAKE SURE GUN/BOW RACK IS COMPLETELY SECURE BETWEEN ROLL BARS BEFORE PLACING WEAPON INTO RACK.

### **STEP 4-**

LOOSEN VELCRO STRAPS ON GUN/BOW CLIPS, PLACE WEAPON INTO CLIPS THEN SECURE WEAPON INTO CLIPS BY RE-ATTACHING VELCRO STRAPS.

- MAKE SURE GUN(S) / BOW(S) ARE PROPERLY SECURED INTO GUN / BOW CLIPS WITH VELCRO STRAPS BEFORE OPERATING VEHICLE.
- DO NOT MOUNT THE "QUICK DRAW" OVERHEAD GUN / BOW RACK IN VEHICLE WHERE
  IT WILL INTERFERE IN ANY WAY WITH THE OPERATION OF THE VEHICLE, I.E.
  STEERING, GAS OR BRAKE PEDALS.
- NEVER TRY TO REMOVE GUN(S) / BOW(S) FROM THE "QUICK DRAW" OVERHEAD GUN / BOW RACK WHILE OPERATING VEHICLE OR VEHICLE IS MOVING.
