

## STANDARD LIMITED WARRANTY

1. **Warranty:** GDI warrants the enclosed products to be free from defects in material and workmanship for a period of 24 months on ramps/12 months on all other products from the date of original retail purchase. GDI warrants the enclosed hardware (where applicable) is delivered to be free from physical defects for a period of 24 months from the date of original retail purchase.

2. **Repair Procedures, Exclusion Remedy:** GDI will, at its option, repair or replace products not conforming to this limited warranty at no charge. THIS IS THE SOLE AND EXCLUSIVE REMEDY AVAILABLE FOR BREACH OF WARRANTY OR UNDER ANY OTHER LEGAL THEORY WITH RESPECT TO GDI PRODUCTS. If you find a product to be defective, contact your authorized GDI representative or GDI Direct. When you receive authorization, return the product as directed, including proof of purchase and purchase date, at your expense and risk. Product repairs not covered by warranty, and product updates, will be provided at a set rate.

3. **Limitations:** This warranty is void if the product is damaged by improper or abnormal use or by accident; if the product is altered or modified in any way other than those directed by official GDI instructions; or if any attempt is made to repair the product without authorization from GDI. It is solely the purchaser's responsibility to determine the suitability of these products for each particular application. GDI products are in all events not suitable, and are not authorized, for use in any situations that might pose potentially injurious to life and health other than those situations that the products are intended for. This warranty is not assignable.

4. **No Other Warranties:** EXCEPT AS PROVIDED IN THIS LIMITED WARRANTY, SET FORTH IN THE WARRANTY CARD SUPPLIED WITH THE GDI ATV PRODUCT AND USER MANUALS ARE PROVIDED "AS IS". ALL OTHER WARRANTIES AND REPRESENTATIONS, ORAL OR WRITTEN, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE EXCLUDED AND DO NOT APPLY. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION OF THE FACE HERE OF. Except as required by law, no representative, agent, or employee of GDI is authorized to make warranties, representations, or obligations inconsistent with or in addition to those set forth in this limited warranty.

5. **No Damages:** IN NO EVENT WILL GDI BE LIABLE FOR DIRECT, INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES RESULTING FROM BREACH OF WARRANTY OR UNDER ANY OTHER LEGAL THEORY, even if advised of the possibility of such damages. In no event will GDI be liable for sums in excess of the purchase price of the product. GDI is thus not liable for lost profits or goodwill; downtime; damage or destruction of items or equipment used with, or in conjunction with, GDI products; personal injury or loss; or any damages.

6. **General:** (a) this agreement is the entire agreement between you and GDI; supersedes any prior or different agreements, representations, or proposals; and may be changed only by written agreement with GDI. (b) Waiver by any party of any default or breach of this agreement will not constitute a waiver of any subsequent default or breach of the same or different kind. (c) The invalidity of any provision of this agreement shall not affect the validity of the other provisions hereof. (d) This agreement shall be governed by the laws of the State of Louisiana, U.S.A.

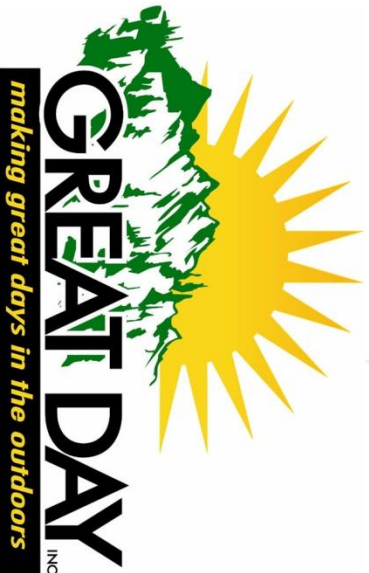

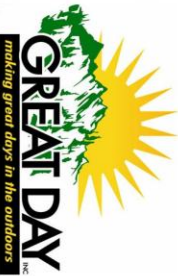

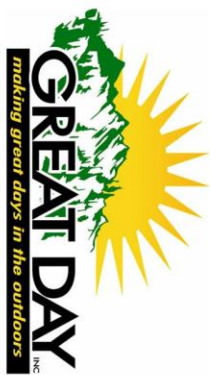
