The Five-Year Limited Warranty is conditioned upon the ladder being operated under normal conditions, use, and proper maintenance in accordance with the owner's manual as supplied with the Xtend+Climb® telescoping ladder).

Xtend+Climb® telescoping ladders are rigorously tested to ensure the ladder you trust is manufactured to the highest standards. Xtend+Climb® ladders are built to withstand normal wear and tear but are not indestructible and can be damaged by misuse and neglect. Our warranty will not cover wear and tear, misuse, improper maintenance, and/or abusive treatment.

### FIVE YEAR LIMITED WARRANTY DETAILS

Core Distribution, Inc., warrants this product to be free from defects in materials or workmanship for a period of five (5) years from the original date of purchase. This warranty does not apply to any damage resulting from: abuse, abnormal usage for which it was not designed, usage beyond normal wear and tear (where worn parts should have been replaced), misuse, improper maintenance and unauthorized alteration(s).
