STEP 1






Warning: Tighten CASTERS (E & F) to POLES (A) completely. Failure to do as instructed could result in the caster stem breaking.

STEP 2







Note: For stability, the lowest SLIP SLEEVES (D) should be installed *no higher* than the 3rd indentation from the caster end of the POLES (A).









Note: The level side of the SHELF (B) is the TOP side (the TRINITY logo on the corner cylinders should be right-side up).





- 4. Do NOT modify the product in any way. Unauthorized modification may impair the function and / or safety of the product, and may affect the life of the product. Any modifications will void product warranty.
- 5. Check for damaged parts. Before using this product, carefully check that all parts are in good condition, and that the product will operate properly and perform its intended function. Check for damaged parts and any other conditions that may affect the operation of this product. Replace damaged or worn parts, and never use this product with a damaged part.
- 6. Do NOT overload the product.

- 9. Lock all locking casters when leaving the product in stationary position.
- 10. Load the product evenly and place the heaviest items on the lower shelves.

- This product is not recommended for outdoor use.

1 YEAR LIMITED WARRANTY

Trinity International Industries ("Trinity") warrants to the original consumer purchaser ("Purchaser") of the TRINITY EcoStorage™ NSF 3-Tier Cart ("Product") that each Product shall be free from defects in workmanship and materials for a period of 1 year from the date of original purchase. Trinity's obligation under this warranty shall be limited to repair or replacement of, or adequate compensation for the Product which shall not be greater than the amount of the purchase price of the Product, at the option of Trinity, during the warranty period. All replaced parts and Products become the property of Trinity and must be returned to Trinity.

This warranty excludes normal wear and tear of the Product and its parts or components, and damage arising from any of the following: negligent use or misuse of the Product, use contrary to this User's Manual, or alteration by any one other than Trinity. The warranty period of 1 year shall not be extended or renewed by the repair or replacement of, or compensation for, the Product. Any warranty implied by applicable law is limited in duration to one year from the date of purchase and is subject to the same conditions and limitations as is provided for our express warranty.
