

## PARTS LIST

Your TRINITY EcoStorage<sup>™</sup> 4-Tier Wine Rack should include the following parts. Please inspect box contents to ensure you have received all components.

You will need no additional tools for assembly.







POLE CONNECTOR (4) Only use when connecting another unit to make a 8-Tier Wine Rack

Please inspect box contents to ensure you have received all components.

Note: The black circular plastic tops in between the Shelves are used only for packaging purposes. They are NOT NEEDED. Please discard.

## **ASSEMBLY INSTRUCTIONS**

## **STEP 1: SLIP SLEEVES**

Note that each POLE (A) has slight horizontal line indentations at 1" intervals. Each SLIP SLEEVE (C) has raised horizontal lines inside designed to lock them in place on the POLE (A).

On the POLE (A), place 1 pair of SLIP SLEEVES (C) at the desired level. Please make sure the arrow faces up and that the word "TOP" is right side up. Do this for each POLE (A) and make sure that the heights are identical for POLE (A).

Slide the pair of SLIP SLEEVES (C) until you hear a click to confirm the pair is locked onto the POLE (A). DO NOT place more than one pair on each POLE (A) at a time.

\* For safety and stability, the lowest SHELF (B) should be lower than the 3<sup>rd</sup> notch from the bottom. \*\* Note: There will be a very small gap in-between the SLIP SLEEVES (D)—this is normal.


### **STEP 2: INSTALLING BOTTOM SHELF**


Place SHELF (B) on its side and slide the (4) POLES (A) through the holes in the SHELF (B). Make sure that the SHELF (B) corner cylinders are positioned over the SLIP SLEEVES (C).


Stand the unit upright.

\*Note: The TRINITY logo on the corner cylinders should be rightside up.

\*\*Use a rubber mallet, if needed, to secure the SHELVES (B).


## **STEP 3: INSTALLING SHELVES**

On POLE (A), place 1 pair of SLIP SLEEVES (C) at the desired distance between SHELVES (B). Please make sure the arrow faces up and that the word "TOP" is right side up. Do this for each POLE (A), and make sure that the heights are identical for each POLE (A).


Lower SHELF (B) over the POLES (A) so that the corner cylinders of the SHELF (B) are positioned over the SLIP SLEEVES (C).

\*\*Use a rubber mallet, if needed, to secure the SHELVES (D).

Repeat Step 3 to install other SHELVES (C) as desired.





## **STEP 4: FEET LEVELERS**

The Feet Levelers are already screwed into your POLES (A) and you can adjust as needed to ensure your Shelving Rack is level.


## **OPTIONAL: 8-TIER WINE RACK**


Purchase another TRINITY 4-TIER WINE RACK. Fully assemble one unit first. Remove BLACK END CAPS from all the poles.

Screw POLE CONNECTORS (D) to second unit's loose POLES where the END CAPS have been taken off.

Screw POLES (A) with the POLE CONNECTORS (D) to the top of the POLES (A) of the assembled unit.

Install remaining SHELVES (B) in desired positions.


