PRODUCT INFORMATION

Easy to use Aquashadow® Blue Lake and Pond Colorant Pouches are a blended formulation of water soluble dyes packaged in a convenient water soluble pouch. Shade your pond a beautiful blue year-round to improve the appearance of off-colored or murky water. This product is for use in lakes, ponds, decorative features and bodies of water with limited outflow.

Quick and easy application!

DIRECTIONS FOR USE:

1. Toss in one pouch per acre-foot of water.

Length (ft.) x Width (ft.) x Average Depth (ft.)/43,560 = Acre Feet

Note: One Acre-foot = 326,000 gal. = 1,234m³

- If multiple pouches are needed, space evenly around the pond. Dye will disperse evenly within several hours, depending upon water movement.
- Maintain color year-round by adding product as needed, following dilution or water exchange.

Do not handle pouch with wet hands or gloves or place on wet surfaces. Chlorine or oxidizers will cause this product to fade.

WATER USE RESTRICTIONS: Allow several hours for dye to disperse before swimming, irrigating, fishing, or allowing animals to drink or enter the water. Do not apply directly to drinking water sources. When used at recommended dosage rate, treated water will not stain exposed surfaces or harm fish, waterfowl, pets or wildlife.

FIRST AID

IF INHALED: Remove individual to fresh air. Seek medical attention if breathing becomes difficult or if respiratory irritation develops. **IF ON SKIN OR CLOTHING:** Flush skin with water for 15minutes. Take off all contaminated clothing and dispose. Seek medical attention if irritation develops. **IF IN EYES:** Flush eyes with plenty of water for at least 15 minutes. Seek medical attention if irritation develops. **IF SWALLOWED:** Immediately drink water to dilute. Seek medical attention if symptoms develop. Never give anything by mouth to an unconscious person.

PRECAUTIONARY STATEMENTS: Contains Acid Blue 9. May cause eye or skin irritation. Do not get in eyes, on skin or on clothing. Wear waterproof gloves when handling. Do not taste or swallow. Wash hands thoroughly with soap and water after use. Concentrated product can stain fabric and other porous surfaces. Avoid direct contact with these materials.

STORAGE & DISPOSAL: Store in cool place in closed container. Do not freeze. Freezing may cause pouch to become brittle. Keep pouches in original packaging until ready for use. Do not reuse empty pails. Rinse empty pail, offer for recycling or dispose of according to state and local regulations. In case of spill, DO NOT ADD WATER. Gently sweep dry dye and dispose of properly. Do not reuse broom or dustpan without cleaning completely. If product has become wet, absorb water and dye with toweling and dispose of. Clean small sections at a time with a light bleach solution, until finished.
