

#### WARNING

- ▲ Failure to follow all warnings listed could result in serious injury or death.
- ▲ Failure to discard and remove this safety rope from service after 3 years from manufacture date, when any signs of damage or wear exist, or after arresting a fall, could result in serious injury or death.
- ▲ This product carries a strict weight restriction of 300 lbs. **Do Not** use this product if you exceed the total weight limit. Please note that the total weight limit includes the user and their equipment.
- ▲ Always inspect this product and all safety devices each time before use and **Never** use a damaged or expired product.
- ▲ Never use this product during inclement weather such as rain, lightning, windstorms or icy conditions and end your hunt and return to the ground if inclement conditions arise.
- ▲ Never use this product when it has been exposed to moisture and has then froze. If it is stiff and frozen or covered in ice or frost, do no use it until it has thawed completely.
- ▲ Never use this product while feeling ill, nauseous or dizzy, or if you have a prior medical condition that could cause a problem, that is, heart condition, joints that lock-up, spinal fusions, etc., or if you are not well rested.
- ▲ **Never** rely on a tree branch for support.
- ▲ Before attempting to use this safety rope, practice installing, set-up, and use at ground level. Once you become comfortable with its set-up and use, you may proceed and use it at heights above ground.
- ▲ **Never** modify this product in any way by making repairs, replacing parts, or altering it.
- ▲ Instructions shall be kept in a safe place and reviewed at least annually. It is the responsibility of the owner to furnish the complete instructions to any person who borrows or purchases this product.
- ▲ Read and understand the manufacturer's warnings, expiration date, and instructions on how to properly use.
- ▲ **Never** use on a dead, leaning, diseased or loose barked tree, or a utility pole. Always avoid electrical power lines.

### WARNING

- ▲ Always store your safety rope out of direct sunlight and any other harsh environmental condition(s) that may adversely affect its performance. Failure to do so could result in serious injury or death.
- ▲ Failure to follow safety rope and harness instructions could result in not being able to return to the stand and being suspended in a harness after a fall. If others are not aware of your hunting location and if your communication efforts are unsuccessful, you must have a personal plan for recovery/escape before you ascend the tree because prolonged suspension in a harness can be fatal. It is important to exercise the legs by pushing against the tree or doing other forms of continuous leg exercises to avoid blood pooling while being suspended. Hunters with varying degrees of physical fitness may require different plans to recover/escape to avoid the effects of prolonged suspension. Have a personal plan and practice it in the presence of a responsible adult before leaving the ground. No one escape/rescue plan will work for every hunter on every tree in every circumstance. Only you can determine the best recovery/escape plan for your hunting situation and you must have a recovery/escape plan for your situation before leaving the ground.



#### WARNING

- A You must wear a full body harness (fall arrest system) at all times after leaving the ground. You must stay connected at all times after leaving the ground while using this product. Failure to follow these instructions may result in serious iniury or death!
- A Prior to attempting to use this product, it is important to become familiar with the assembly, setup, installation, use, and removal at ground-level. Failure to follow these instructions may result in serious injury or death!
- ▲ When using the Rivers Edge® Safety Rope, only one user should ascend or descend the tree at a time. Failure to follow these instructions may result in serious injury or death!
- Always test the Prusik knot before each use. Do so by gripping the rope just above of the Prusik knot with one hand and pulling sharply on the carabiner with the other hand. Be sure that it tightens securely. If it does not or you are uncertain about its effectiveness, **DO NOT** use it.
- ▲ Never hold the Prusik knot constantly while climbing. Grabbing or holding the Prusik knot in the event of a fall could cause you to slide down the entire length of the rope resulting in serious injury or death.
- **A Never** wash this product in a washing machine.
- **A Always** keep this safety rope out of direct exposure to ozone generated by an ozone generator/machine.
- ▲ Never use this product when it has been exposed to moisture and has then froze. If it is stiff and frozen or covered in ice or frost, do no use it until it has thawed completely.

#### **SET-UP & USE INSTRUCTIONS**

- 1. Put on your safety harness making all necessary adjustments and safety checks as per the manufacturer's instructions.
- 2. Climb up and once you have reached your climbing height, attach the safety rope to the tree just above the treestand by wrapping the knotted loop end around the trunk and then pulling the rest of the line through the knotted loop until snug [ SEE FIGURE 1 ].
- 3. Using the carabiner, attach the harness tether to the loop on the Prusik knot while making sure that the knot is able to move down the length of the rope without interference [ SEE FIGURE 2 ].
- 4. Next, descend the tree while regularly adjusting the Prusik knot so that it is always just above you. **DO NOT** pull/hold the Prusik knot constantly while descending as this may cause the safety rope to fail, resulting in injury or even death.
- 4. Once on the ground, disconnect the harness from the Prusik knot and loosely tie the bottom of the safety rope to the base of the tree [ SEE FIGURE 3 ]. Make sure that the Prusik knot is still able to move from the top to the bottom of the tree without interference.










### WARNING

▲ This product is designed to work properly when the Prusik knot has 6 loops. The Prusik knot should be inspected BEFORE each use and should NOT be used unless all 6 loops are present. Failure to follow this warning may result in serious injury or death!
