

# WARRANTY

## LIMITED WARRANTY

**WITH PROOF OF SALE:** the following warranty coverage applies when this appliance is correctly installed, operated and maintained according to all supplied instructions. Note: Consumer is responsible for shipping & handling of all warranty replacement parts.

**FOR ONE (1) YEAR FROM THE DATE OF ORIGINAL PURCHASE:** from the date of sale this heater is warranted against defects in material or workmanship, consumer will receive free replacement parts with proof of purchase, consumer is responsible for shipping & handling cost.

All warranty coverage excludes paint loss, discoloration or surface rusting, which are either expendable parts that can wear out from normal use within the warranty period, or are conditions that can be the result of normal use, accident or improper maintenance.

All warranty coverage is void if this appliance is ever used for other than private household purposes.
