

PRORUN Limited Warranty

Warranty Coverage:

PRORUN, a brand under Topsun USA Inc., warrants that its products are free from defects in material or workmanship under normal use and maintenance. The company will, at its discretion, repair or replace any defective product or part covered by this Limited Warranty, free of charge at any authorized Servicing Dealer/Center using OEM replacement parts, subject to the limitations and exclusions described below.

Limited Warranty Period:

PRORUN products are warranted to the original retail purchaser from the date of retail purchase for the applicable period of time specified in the product documentation or as listed below. Please note that certain products may have extended warranties as indicated.

What is NOT Covered:

This Limited Warranty does not cover:

- Replacement of normal wear parts, including but not limited to air filters, belts, blades (excluding normal wear for electric units), fuel filters, lubricants, spark plugs, seats, etc.
- Damage caused by improper use, neglect, modifications, improper servicing, or use of unauthorized attachments.
- Damage resulting from the use of improper fuel or failure to follow prescribed fuel and oil usage.
- Damage caused by external factors such as accidents or events beyond PRORUN's reasonable control.
- Damage due to improper setup, pre-delivery service, or repair service by unauthorized personnel.
- Damage to batteries, including failure due to discharge or improper voltage use, is not covered under this warranty. Please note that batteries can be susceptible to damage from improper storage, particularly in extreme low temperatures. It is recommended that users store batteries indoors during the winter or any period of extreme temperature to prevent potential damage.
- Damage due to exposure of products to temperatures outside product specifications.

Your Responsibilities:

To maintain your rights under this Limited Warranty, you must exercise reasonable care and use of the product as outlined in the operator's manual. Failure to perform required maintenance as described will void this warranty. Additionally, you must cease using the product immediately upon any failure or damage and take it to an authorized servicing dealer for inspection.
