





A NOTE ON ANCHORS


The anchors included with this product are only intended for use with concrete and/or brick. While standard anchors intended for use with concrete and/or brick walls are included with this mounting bracket, it remains the responsibility of the person installing the mounting bracket to determine which anchor type should be used for each specific installation and/or type of substrate. Please ensure that appropriate pullout tests are performed prior to installation.

If you are unsure about what type of mounting hardware you should use, please ask a professional for assistance.



INSTALLATION INSTRUCTIONS

1. Place the crossbar A straight and even against the wall. Use the built-in level in the crossbar A to keep the bar straight. Then, mark on the wall with a pencil or marker where three (3) holes need to be made, indicated by the three (3) holes in the crossbar A.



- 2. Drill three (3) holes in the wall at the marked locations and insert three (3) wall anchors **3**. Line up the anchors with the holes in the crossbar **4** and insert the three (3) expansion bolts **9**. Tighten the bolts so the crossbar **4** is firmly in place.
- 3. Unfold the two (2) L-shaped brackets **B** and slide the brackets onto the crossbar **A** from the ends of it. Then, adjust the spacing between the two (2) L-shaped brackets **B** so they are in the desired position. Reposition the adjustable wall anti-vibration pads on back of the L-shaped brackets **B** against the wall (if needed).



- 4. Once the the L-shaped brackets are in the right position, mark the wall where the holes need to be made indicated by the two (2) holes on each L-shaped brackets D. Drill four (4) holes in the wall, insert four (4) wall anchors I line up the anchors with the holes on the brackets, and fasten the four (4) expansion bolts os the L-shaped brackets are firmly in place.
- 5. Fasten a 2 ½ screw **⑤**, split lock washer **⑥**, washer **⑥**, and hex nut **⑥** in the joint of each L-shaped bracket **⑥** so the L-shaped brackets stay in place.

6. Fasten a 1 1/8 screw ①, washer ①, hex nut ①, and rubber pad ② onto a hole on the horizontal part of the L-shaped bracket ③, two holes should be used for each L-shaped bracket ③.



NOTE: Make sure to use the holes in the L-shaped brackets that correspond to the size of your air conditioner so the AC unit can be properly mounted to the bracket.

7. Place your split air conditioner onto the mounting bracket. Fasten the split air conditioner onto the brackets using the four (4) rubber pads **S** to secure the unit in place.

TO REMOVE AC UNIT:

- 8. Unscrew the 1 1/2 screws **1** and rubber pads **1** from the air conditioner at the bottom of the brackets.
- 9. Lift the air conditioner off the brackets.
- 10. Fold up the L-shaped brackets **B** when not in use.
