EcoStrong's Drain & Fruit Fly Eliminator will eliminate all types of flies that live and breed in drains, pipes and garbage disposals.

The light gel contains a unique mixture of detergents and essential oils. When poured down the drain, the detergents clings to the walls of the pipes and destroys the fly's breeding and development habitat (known as drain scum or bio film). The essential oils both kill and repel the flies from coming back. With no place to live, the remaining flies die off. Not only are flies gone, so are drain odors! This product is safe for all types of plumbing including septic systems.

BEFORE USE: Read the entire label and follow the directions carefully. Shake the bottle vigorously before each use. Fill the sink full of water and drain quickly before first use. This will wash any food particles away. Wait 2 hours for the drain to dry then start treatment. Always treat at low flow times such as before bed. Ideally the drain or sink will not be used for six hours after treatment

SINKS & DRAINS: Pour 8 oz of product down the drain around the edges to coat all sides of the drain. Repeat every day until flies disappear. Serious infestations can last up to 3 weeks. Use weekly as a prevention plan.

GARBAGE DISPOSALS: Follow the instructions above but turn the garbage disposal on while pouring the product down the drain. This will coat the surfaces inside the disposal.

DOUBLE SINK DRAINS: If one side of the sink's drain pipe is a longer distance to the P-trap, the treatment won't reach the extended pipe length to remove drain scum. Mix 8 oz. of the product with 4 oz. of water, pour it down the longer run, and repeat daily for a week. Continue treating the shorter as usual.
