IMPORTANT SAFETY INSTRUCTIONS:

This portable lamp has a polarized plug (one blade is wider than the other). As a safety feature to reduce the risk of electrical shock and fire, this plug will fit in a polarized outlet only one way. If the plug does not fit fully in the outlet, reverse the plug. If it still does not fit, contact a qualified electrician. Never use with an extension cord unless the plug can be fully inserted. Do not alter this safety feature.

This lamp is for indoor use only. The lamp should not be used near water. Never immerse the lamp in water or other liquids. Never cover the lamp with any object including cloth or paper as this is a fire hazard. Do not handle the bulb immediately after the light is turned off as it will be hot. This is not a toy. It is recomended that you wear gloves during assembly.

**PLEASE NOTE:

1. THE PARTS NEEDED FOR ASSEMBLY OF THIS LAMP WILL BE LOCATED IN ONE OR MORE OF THE CORNER CARDBOARD TRIANGLES INSIDE THE BOX


2. THE SAUCER PLATES ARE VERY PLIABLE, IF BENDING HAS OCCURRED THEY CAN EASILY BE MOLDED BACK INTO THEIR ORIGINAL SHAPE.

ASSEMBLY INSTRUCTIONS:

- 1. Screw the lower lamp body pole (1) into the base of the lamp.
- 2. Screw the upper lamp body pole (2) into the lower lamp body pole (1).
- 3. Tighten the rod (3) to the housing of the upper lamp body pole (2).
- 4. Hang crystal drops (5) onto the acrylic saucer plates.
- 5. Hang strings of crystals (4) from the upper middle iron plate to the acrylic saucer plates on either side.
- 6. Place the metal tubes (6) into the acrylic saucer plate pipes.
- 7. Install bulbs (7). Only use bulbs of specified type and maximum rated wattage or less.

8. Remove the protective plastic from the lamp shade (8) and secure the lamp shade (8) to the rod (3) with the screw finial (9).

9.. Plug the electrical supply cord into the wall outlet.



Requires 3 x 40W equivalent type B candelabra base bulbs

CLEANING & MAINTENANCE:

1. Unplug the fixture before cleaning.

- 2. Use a clean, dry, soft, lint-free cloth.
- 3. Do not use water or other chemical cleaning agents.

Installation of the replacement products or replacement parts shall be at Buyer's expense.

2. Exclusive Obligation:

THIS WARRANTY IS EXCLUSIVE. The sole and exclusive obligation of Manufacturer shall be to repair or replace the defective products in the manner and for the period provided above. Manufacturer shall not have any other obligation with respect to the products or any part thereof, whether based on contract, tort, strict liability or otherwise. Under no circumstances, whether based on this Limited Warranty or otherwise, shall Manufacturer be liable for incidental, special, or consequential damages.

3. Other Statements.

Manufacturer's employees or representatives' oral or other written statements do not constitute warranties, shall not be relied upon by Buyer, and are not part of the contract for sale or this limited warranty. 4. Entire Obligation.

This Limited Warranty states the entire obligation of Manufacturer with respects to the products. If any part of this Limited Warranty is determined to be void or illegal, the remainder shall remain in full force and effect.
