IMPORTANT SAFETY INSTRUCTIONS:

This portable lamp has a polarized plug (one blade is wider than the other). As a safety feature to reduce the risk of electrical shock and fire, this plug will fit in a polarized outlet only one way. If the plug does not fit fully in the outlet, reverse the plug. If it still does not fit, contact a qualified electrician. Never use with an extension cord unless the plug can be fully inserted. Do not alter this safety feature.

This lamp is for indoor use only. The lamp should not be used near water. Never immerse the lamp in water or other liquids. Never cover the lamp with any object including cloth or paper as this is a fire hazard. Do not handle the bulb immediately after the light is turned off as it will be hot. This is not a toy.

ASSEMBLY INSTRUCTIONS:


 Carefully remove all parts from the carton.
Gently pull the cord from the bottom of the lamp until the Socket Assembly (B) is close enough to screw into Base (A)
Screw Socket Assembly (B) Counter Clockwise until tight

3. Screw Socket Assembly (B) Counter Clockwise until tight against Base (A)

4.Place Harp (D) into Saddle (C)

5. Place Shade (E) onto Harp (D) and secure in place with Finial (F)

6. Screw in light bulb into the lamp and enjoy!



Requires 1 x 40W equivalent Type A medium base bulb (not included)

CLEANING & MAINTENANCE:

1. Unplug the fixture before cleaning.

2. Use a clean, dry, soft, lint-free cloth.

3. Do not use water or other chemical cleaning agents.

Installation of the replacement products or replacement parts shall be at Buyer's expense. 2. Exclusive Obligation:

THIS WARRANTY IS EXCLUSIVE. The sole and exclusive obligation of Manufacturer shall be to repair or replace the defective products in the manner and for the period provided above. Manufacturer shall not have any other obligation with respect to the products or any part thereof, whether based on contract, tort, strict liability or otherwise. Under no circumstances, whether based on this Limited Warranty or otherwise, shall Manufacturer be liable for incidental, special, or consequential damages.

3. Other Statements.

Manufacturer's employees or representatives' oral or other written statements do not constitute warranties, shall not be relied upon by Buyer, and are not part of the contract for sale or this limited warranty. 4. Entire Obligation.

This Limited Warranty states the entire obligation of Manufacturer with respects to the products. If any part of this Limited Warranty is determined to be void or illegal, the remainder shall remain in full force and effect.
