

4-Methyl pyrazole (Antizol TM) is an effective blocker of alcohol dehydrogenase and should be used in the treatment of ethylene glycol, di- or triethylene glycol, ethylene glycol butyl ether, or methanol intoxication if available. Fomepizol protocol (Brent, J. et al, New England Journal of Medicine, Feb 8, 2001, 344:6, p. 424-9): loading dose 15 mg/kg intravenously, follow by bolus dose of 10 mg/kg every 12 hours; after 48 hours, increase bolus dose to 15 mg/kg every 12 hours.
