

THE EASY WAY TO GET RID OF TREE STUMPS

READY-TO-USE

DECOMPOSES WOOD, MAKING IT POROUS DOWN TO THE ROOT

KEEP OUT OF REACH OF CHILDREN CAUTION HARMFUL IF SWALLOWED

DIRECTIONS FOR USE

HOW IT WORKS: Gordon's Stump Remover decomposes the wood of the tree stump, leaving it porous right down into the root tips. After 4-6 weeks, kerosene is poured onto the stump and the stump is ignited. The stump and roots will burn a low, smoldering flame, not a big jumping flame.

FOR STUMPS ABOUT 12 INCHES TO 18 INCHES WIDE: Drill a 1 inch diameter hole straight down from the top of the stump to a depth of about 10 inches. Then, into the side of the stump about 4 or 5 inches down from the top, drill a 1 inch wide hole **slanting downward toward the bottom of the vertical hole**. The holes should meet or be close together (see illustration). It is important to drill the side hole slanting downward to direct the solution into the crown and roots. Also, when the holes meet, the natural ventilation helps to destroy the stump more quickly when ignited.

Next, pour at least 4 ounces Gordon's Stump Remover into each hole. Fill with water and let stand. After 4 to 6 weeks, fill the holes with kerosene or fuel oil and let stand until completely absorbed into the stump. Next, pour just enough kerosene or fuel oil into the stump to ignite it. Or, burn charcoal on top of the stump or around the base to start the stump burning. The stump will burn with a smoldering, red glow, clear down to the roots, until only ashes are left.

For quicker stump destruction, bore 2 sets of holes into the stump and pour 4 to 6 ounces Gordon's Stump Remover into each hole. Proceed as directed.

FOR LARGE DIAMETER STUMPS: For stumps wider than 18 inches, drill 2, 3 or more sets of vertical and slanting holes into the stump. Pour 4 to 6 ounces Gordon's Stump Remover into each hole and proceed as directed.

CAUTION: HARMFUL IF SWALLOWED. Contains potassium nitrate. If swallowed, give one or two glasses of water or milk and call a physician. Avoid contact with eyes, skin, and clothing. Should contact occur wash with plenty of water.
