



LIMITED WARRANTY:

World Marketing of America, Inc. warrants that this Reddy Heater to be free from defects in material and workmanship for a period of two (2) years. This warranty is limited to the original purchaser (NON-TRANSFERRABLE) and requires proof of purchase such as an invoice, cancelled check, sales receipt, etc. This warranty is limited to defects in material and workmanship and does not cover normal maintenance required to maintain proper operation of the heater, specifically not covered under this warranty is the replacement of rotors, filters, fuses, and ignitors.

This warranty does not apply to products purchased for rental use.

DUTIES OF THE OWNER:

This heating appliance must be operated in accordance with the written instructions furnished with this heater. This warranty shall not excuse the owner from properly maintaining this heater in accordance with the written instructions furnished with this heater. A bill of sale canceled check or payment record must be kept to verify purchase date and establish warranty period. Original carton should be kept in case of warranty return of unit.

WHAT IS NOT COVERED:

1. Damage resulting from the use of improper fuel.
2. Damage caused by misuse or use contrary to the owner's manual and safety guidelines.
3. Damage caused by a lack of normal maintenance.
4. Fuses
5. Use of non-standard parts or accessories.
6. Damage caused in transit. Freight charges on warranty parts or heaters to and from the factory shall be the responsibility of the owner.

In the event of a defect, this Limited Warranty shall be limited to the repair or replacement of parts, which prove defective under normal use and service within the limited warranty period.
