DURACLAD® Interlocking Wall & Ceiling Panels 20 Year Limited Warranty

Definitions

“DURACLAD” Interlocking Wall & Ceiling Panels (hereinafter the “Product”) are hereby warranted by Palram Americas, Inc. (hereinafter the “Manufacturer”), subject to the terms contained herein.

Scope of Warranty

This warranty applies only to the party who owns (the “Owner”) the facility where the Product is installed when the Product is installed. In this warranty “Owner” shall also mean a lessee or sub lessee who installs the Product or contracts to have it installed at a leased property which it occupies at the time of installation.

Manufacturer warrants that the Product shall maintain the following characteristics for the specified time period from Commencement Date.

20 Year Warranty

For a period of twenty (20) years the Product shall maintain the following:

- Surface Degradation: Will maintain good surface condition. Will not corrode or rot or be affected by dampness.
- Structural Rigidity: Will maintain the same rigidity in service as it had when purchased, when used in the temperature and other environmental conditions recommended by Manufacturer.
- Safety: Will remain non-flammable according to the ASTM D635-22 standard. A “Defect” will mean the Product fails to comply with one or more of the foregoing warranties.

Commencement Date

The commencement date of this Warranty (the “Commencement Date”) shall be the date of the Product’s manufacture or, if such date does not appear on the Product, the date the Product was purchased from an authorized dealer or retailer.

Limitations

This warranty shall be valid only if:

- The original proof of purchase is presented.
- The Product is stored, installed, handled, cleaned and maintained in accordance with the Manufacturer’s written instructions which are available on-line at www.Duraclad.com. In accordance with Manufacturer’s policy of continual Product development users and installers should check with their local supplier or Manufacturer’s web sites to ensure that users have obtained the most up to date information.
- The Product is used for interior applications only, in a customary fashion, and not where exposed to the weather.

The Product is not warranted against natural disasters or color changes due to exposure to sunlight, artificial ultraviolet light sources, smoke, fumes or incompatible chemicals. See www.Duraclad.com for a non-exclusive list of certain chemicals known to be incompatible with the Product. However, responsibility remains with the owner or end user to test for and determine chemical compatibility with the proposed application.

This warranty does not cover any costs and expenses of removal and installation of the Product or taxes or shipping cost or any other direct or indirect losses which may result from the Product Defect.

Manufacturer has no control over the use to which others may put the material, and therefore Manufacturer does not guarantee that the same results as those described herein will be obtained.

Claims and Notifications — Every warranty claim must be submitted in writing to the Manufacturer or original dealer promptly after occurrence

of Product Defect, enclosing the original sales receipt or other proof of purchase, photographs of the issue and this warranty. Owner may make only one claim under the warranty against the Defect for any particular installation over the lifetime of the Product. The claimant must allow the Manufacturer an opportunity to inspect any or all of the sheets involved and the installation site itself while the sheets are still in their original position and have not been removed, moved or altered in any way, or upon the Manufacturer’s request, return a sample of the sheets to the Manufacturer for testing. The Manufacturer reserves the right to investigate independently the cause of any failure.

Compensation — If a claim is covered under this warranty, the Manufacturer will provide the Owner with free replacement Product or, at the Manufacturer’s discretion, refund all or part of the original purchase price paid by Owner, in accordance with the Refund Tables listed below. Replacement Product is warranted only for the balance of the original warranty on the original Product.

Refund Tables

If over a specific period of time the Product exhibits a Defect as previously defined and the Manufacturer elects to make a refund rather than supply replacement Product, the applicable refund percentages are as follows, based on the time elapsed from the Commencement Date to the time the loss is reported to the Manufacturer:

| Time Elapsed After Commencement Date | Owner will be refunded this percentage of original purchase cost |
|--------------------------------------|--|
| End of 10th year | 100% |
| End of 11th year | 50% |
| End of 12th year | 45% |
| End of 13th year | 40% |
| End of 14th year | 35% |
| End of 15th year | 30% |
| End of 16th Year | 25% |
| End of 17th Year | 20% |
| End of 18th Year | 15% |
| End of 19th Year | 10% |
| End of 20th Year | 5% |

Example:

If by the end of the twelfth year the Product has lost its ability to remain structurally rigid, The Manufacturer would elect either to provide 100% replacement Product or refund 45% of the original cost of the Product.

Jurisdiction

This limited warranty shall be governed by and shall be construed according to the laws of the Commonwealth of Pennsylvania, USA. Any claim or dispute related to the Product and/or this warranty shall be exclusively brought before the appropriate court in the Commonwealth of Pennsylvania, USA, which shall have the exclusive jurisdiction in any such claim or dispute.

THIS LIMITED WARRANTY SHALL BE THE MANUFACTURER'S SOLE WARRANTY APPLICABLE TO THE PRODUCT.
