OPERATING INSTRUCTIONS

BEFORE USE: Remove tail cap and remove plastic tab on battery.

BATTERY REPLACEMENT: Install battery by first removing tail cap. Place one 2P 26650 (7.4 volts) rechargeable battery with positive (+) end toward head of flashlight as shown. Make sure the spring is in the tail cap. Replace tail cap by screwing in securely.

BATTERY RECHARGING: Use USB-C charging cord. Lift protective cover of Charging port and plug USB-C cord into charging port. Power button indicator will turn green when fully charged.

PUSH BUTTON SWITCH: Press button switch on side of barrel to cycle through modes: High, Med, Low, Strobe, SOS. When light is on, press button for three seconds to enter turbo mode. Turbo mode will automatically turn off after 30 seconds.

1-YEAR LIMITED WARRANTY: This product is guaranteed to be free of defects in material and workmanship for one year from date of purchase to the original owner. If this product is defective, call our Customer Service at 855-735-9922 for repair or replacement parts or return the product to store from which it was purchased.
