LIMITED WARRANTY FOR THE UNITED STATES OF AMERICA AND CANADA

Provided the warranty claim is preliminarily approved, you must return the complete product to any SKIL Factory Service Center or Authorized Service Station. The purchaser is responsible for transportation of the product (including any attachments) at their expense to and from the Authorized FLEX Service Stations.
